Ilmo Sr. Comandante:

Acerca dos fatos e atos de violência ocorridos na data de ontem, 16 de novembro de 2025, durante o jogo Avaí x Remo válido pelo Campeonato Brasileiro da Série B, vimos informar o que segue e ao final requerer:

No início do dia, por volta das 9 horas da manhã, funcionários do Avaí Futebol Clube começaram a acompanhar a movimentação de torcedores de ambas as torcidas na parte externa do estádio da Ressacada.

Por ser considerado um jogo de risco (em razão da rivalidade de torcidas organizadas) o clube previamente informou à PMSC que os cuidados com a segurança deveriam ser redobrados.

No início da tarde um veículo UBER, desconhecedor da divisão de espaços e vias para as torcidas local e visitantes ingressou com torcedores do Remo no interior do veículo, passando no meio da concentração da torcida local, o que gerou um primeiro episódio de confronto e violência, com danos materiais ao veículo e agressões entre os torcedores.

O episódio gerou pronta atuação da PMSC e em conjunto com os funcionários do Avaí Futebol Clube os ânimos foram arrefecidos e o cuidado com a divisão de torcedores foi redobrado, permitindo que até o início do jogo os torcedores adentrassem ao Estádio sem maiores conflitos.

Com o início do jogo ficou claro que os torcedores do Clube de Remo haviam comprado ingressos em outros setores que não apenas o setor a eles reservados. Foram identificados torcedores nos setores F, G e H. Há relatos ainda de torcedores do Remo também no próprio setor A (exclusivo da torcida do Avaí).

Por volta das 15 horas o setor de relacionamento com os torcedores começou a receber relatos de presença e provocação com cânticos e xingamentos no setor D do clube, o que fez com que a Polícia Militar fosse novamente informada do ocorrido.

Logo no início da partida (por volta dos 15, 20 minutos do primeiro tempo) a Polícia Militar deslocou uma guarnição para o Setor E (divisor da torcida do Avaí com a torcida visitante) e **numa operação muito bem conduzida, com calma, educação e conformidade** conseguiu retirar todos os torcedores visitantes do

Setor E, direcionando-os ao setor visitante. Temporariamente a situação foi resolvida.

No entanto, logo após realizar a separação a guarnição da Polícia Militar deixou o local (quando, talvez, o melhor fosse sua permanência com um cordão de isolamento de policiais militares).

Assim, um pouco antes do término da partida, embora o Avaí houvesse reforçado sua segurança privada, um grupo de torcedores do Remos (a maioria identificados com uniformes e bandeiras de uma torcida organizada) comandou uma invasão pelo portão de acesso ao setor E, destruindo o portão e agredindo violentamente os orientadores (segurança privada) que não resistiu à força do grande grupo de torcedores do Remo não obtendo sucesso na retenção.

Após arrombarem o portão de acesso e agredirem os seguranças do clube, dezenas de torcedores em grupo partiram em direção à torcida do Avaí (num setor familiar com mulheres e crianças) agredindo-os violentamente.

Diante da confusão a Polícia Militar que atuava dentro do gramado conseguiu dissipar a invasão com bombas de efeito moral, retornando às arquibancadas para controle da turbacão, voltando a dominar a segurança local com auxílio dos orientadores do clube.

Por isso, o Avaí Futebol Clube entende que o episódio demanda novo estudo da organização dos jogos de futebol, sobretudo aqueles de alto risco.

O Avaí Futebol Clube e a Polícia Militar de Santa Catarina detêm excepcional histórico de controle dos espetáculos. Prova disso é que no ano de 2025 dezenas de jogos foram realizados na Ressacada sem qualquer relato de violência, tudo fruto do bom trabalho desenvolvido em conjunto entre as duas instituições.

Assim sendo, o Avaí Futebol Clube vem agradecer mais uma vez à parceria desenvolvida com a Polícia Militar de Santa Catarina, requerendo a designação de uma reunião para que o episódio seja avaliado com a sugestão de melhorias para que possamos cada vez mais oferecer segurança e conforto a todos os torcedores – locais e visitantes – que frequentam os eventos desportivos no Estádio Aderbal Ramos da Silva.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Avai Futebol Clube (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

Consequences of changing your mind
